Administrative / Biographical history Brian Benson is a Brisbane-based film maker and motion picture photographer. Vic Rail was a well-known South East Queensland horse trainer. In September 1994, a virus broke out amongst Rail's horses at his training complex in the Brisbane suburb of Hendra. Vic Rail and the stable foreman Ray Unwin both then contracted the disease from the horses. Rail passed away within weeks from related symptoms. 14 of the 21 horses involved also died.
