Abstract The collection includes significant items representing key aspects of the life and legacy of Eddie Koiki Mabo, as well as items that provide information regarding his wife Dr. Bonita Mabo AO and their daughter Gail Mabo.

Scope and content The collection includes shirts worn by Eddie Koiki Mabo and his extended family. These include shirts designed by Dr. Bonita Mabo AO often containing personal messages of support for her husband and that celebrate his culture and the successful Mabo High Court case; a shirt supporting the South Australian Pitjantjatjara Land Rights Bill; a shirt worn by Gail Mabo when Prime Minister Tony Abbott AC toured Mer (Murray Island), shirts celebrating National Aboriginal & Torres Strait Islander Week and Mabo Day; National Native Title conference shirts; and a variety of other shirts including a 'Smugglers of Light' Foundation shirt, of which Gail Mabo is the patron and ambassador. Other items include silk screens used by Dr. Bonita Mabo AO to screen print her designs. The collection also includes a variety of publications including corflute posters for Mabo Day 2017; an invitation, ticket and information pack presented to Bonita Mabo for the inaugural Eddie Mabo Memorial Lecture and Dinner 2002 and of great significance the Mabo family's annotated copy of Margaret Lawrie's publication 'Myths and legends of the Torres Strait'.

Administrative / Biographical history Edward 'Koiki' Mabo (1936-1992) was a Torres Strait Islander community leader known for his role in campaigning for Indigenous land rights and for his role in a landmark decision of the High Court of Australia on 3 June 1992 (five months after Mabo's death) which overturned the legal doctrine of terra nullius which characterised Australian law in regard to land and title. Edward Koiki Mabo married Bonita Neehow (ca. 1943-2018), an Australian South Sea Islander, in 1959. The couple had seven children and adopted three more. Their daughter Gail, is an artist and dancer. Koiki Mabo worked on pearling boats, as a cane cutter and as a railway fettler before working as a gardener at James Cook University in Townsville. In 1973 he and Bonita established the Black Community School in Townsville where Indigenous children

could learn about their own culture. In 1981 Mabo gave a speech at a land rights conference at James Cook University which led to the successful Mabo test case.

Biographical history

The shirt was given to Eddie Koiki Mabo when he was invited to Perth to attend a festival as part of the Townsville based New Blood Dance Troupe, founded by Shane and Bronwyn Williams. At the festival he taught cultural dances to other troupes and festival attendees. Eddie Koiki Mabo wore the shirt in support of the Pitjantjatjara Land Rights Bill.

Eddie Koiki Mabo was an advocator of traditional Aboriginal and Torres Strait Islander land rights. The shirt supports the South Australian Pitjantjatjara Land Rights Bill. The Pitjantjatjara

people's traditional lands contain areas in South Australia, Western Australia and the Northern Territory. In early 1979 a Parliamentary Select Committee reported in favour of an Act giving the Pitjantjatjara people total rights over their traditional land in the north west of South Australia. Following this, legislation recognising the traditional rights of the Pitjantjatjara people was introduced by Don Dunstan AC QC's South Australian Labor government. The Bill was before Parliament when there was a change in government in late 1979. There were fears the Bill would be abandoned. The new Liberal government eventually re-negotiated the matter and the Bill became the Pitjantjatjara Land Rights Act 1981 on 19 March 1981. Biographical history

The shirt was given to Eddie Koiki Mabo by Ada Blanco. Eddie Koiki Mabo travelled with his students from the Townsville Black Community School down to Ayr to perform during National Aboriginal and Islander Week, 4-9 July, Ayr, Queensland, 1974. He wore the shirt during National Aboriginal and Islander Week celebrations. Eddie Koiki Mabo and Dr. Bonita Mabo AO were co-founders of the Townsville Black Community School in 1973 as they were

unhappy with the approach to Indigenous education within the Queensland state education system. Eddie Koiki Mabo became director and volunteered to work for half pay to help establish the school. Dr. Bonita Mabo AO worked as a teacher's aide and oversaw the day-to-day operations of the school. This included providing continuity and cultural training to all children. The school endured open hostility from the Townsville community including the Queensland Education Department, the local newspaper and some local politicians at a time when it was considered unacceptable to have separate curricula and teaching policies for Australian Aboriginal and Torres Strait Islander children. The school started with 10 students and was one of the first of its kind to operate. It peaked in the late 1970s with 45 students. Eddie Koiki Mabo was born on the 29 June 1936 in the village of Las on Mer (Murray Island) in the Torres Strait. He was the fourth child of Robert Zesou Sambo and Poipe (Sambo) Mabo. Following the death of his mother shortly after his birth he was adopted by his Uncle Benny and Auntie Maigo Mabo in line with Islander custom. His first language was Meriam and he grew up immersed in Meriam culture and was taught from a young age the importance of respecting other people’s land.
