Abstract Photographs and newspaper clippings relating to Phyllis Ebbage.

Scope and content The collection includes photographs and newspaper clippings relating to the Peel Island Lazaret where Phyllis Ebbage spent 13 years of her life from 1939. The photographs include colour images of Peel Island taken about 2000 and some older family photos. Also included are newspaper clippings and photocopies of newspaper articles relating to Peel Island and the treatment of leprosy (some annotated by Phyllis Ebbage's daughter); and an oral history by Phyllis Ebbage held on cassette tape and a copy of the recording on CD.

Administrative / Biographical history Phyllis Ebbage lived in Ayr, Queensland with her husband and two young daughters and was diagnosed with leprosy (Hansen's Disease) in Townsville in 1940. Despite there being some doubt over the actual diagnosis, and without being told the reason, Phyllis was taken from Townsville to Peel Island, off the coast of South-East Queensland on 26th January 1940. She was not able to return to her home to say goodbye to her daughters, Desley and Verree who were only 5 and 6 years old. It was eight years before saw her children again. Family visits were restricted to once a fortnight for just 30 minutes and the only way to access the island was by taking the government's steamboat. A round-trip took eight or nine hours and no children were allowed. Phyllis' husband, Les Ebbage moved to Brisbane to be closer to his wife and after buying a sailing boat, made secret trips to the island with their two daughters. Eventually Les was caught and despite an outpouring of public sympathy, was fined 10 pounds by a magistrate (the minimum amount prescribed by law). Phyllis Ebbage spent 12 years and 8 months confined to the Lazaret on Peel Island.

Newspaper articles include "Visitor permits to Peel Island"; "... and Peel Island" which talks about how diet may cure leprosy; "Rotary luncheon address", Rockhampton bulletin, 4 October 1946, which talks about an address about improving the conditions of lepers on Peel Island; "Women lepers taken off Peel Island : Brisbane prosecution", Cairns Post, which talks about how Les Ebbage and his father were caught and fined for smuggling his wife and another leper from Peel Island for dinner; and "Abandon Hope : when will Peel Island patients be shown some mercy?", which talks about the treatment and conditions on Peel Island. Other newspaper articles cover subjects such as other leper colonies, treatment of leprosy, infectious diseases and associated people such as Sir Raphael Cilento.

Leprosarium", 24 June 1947 which talks about the building of a new lazaret on Peel Island to replace existing facilities; "Peel Island: heart-rending story of young mother's fight for liberty" which talks about the story of Phyllis and Lee Ebbage; and "Lepers condemned to living death", 24 May 1945, which talks about the conditions on Peel Island. There are also other articles about the treatment of leprosy.
